**A RESOLUTION OF THE BOARD OF DIRECTORS OF THE
CHEROKEE METROPOLITAN DISTRICT AMENDING THE 2018
SCHEDULE OF FEES AND CHARGES APPLICABLE TO DISTRICT
SERVICES.**

WHEREAS, C.R.S. § 32-1-1001(j) authorizes and empowers the Board of Directors of the Cherokee Metropolitan District (the "District") to fix and from time to time increase or decrease fees, rates, tolls, penalties, or charges for service, programs or facilities furnished by the District; and

WHEREAS, C.R.S. § 32-1-1006(1)(g) authorizes and empowers the Board of Directors of the District "to fix and from time to time increase or decrease tap fees; and

WHEREAS, in November 2017, the Board of Directors, after a duly notice public hearing, approved the 2018 Schedule of Fees and Charges;

WHEREAS, the Board of Directors received additional public comment on the 2018 Schedule of Rates and Charges and desires to consider amendments to the rates and charges; and

WHEREAS, after a duly noticed public hearing held on March 13, 2018, the Board of Directors of the District has determined to amend the 2018 Schedule of Fees and Charges.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CHEROKEE METROPOLITAN DISTRICT AS FOLLOWS:

1. The Cherokee Metropolitan District 2018 Water and Wastewater Rates attached hereto as **Exhibit A** is hereby approved and effective as of January 1, 2018 and replaces completely the previously adopted 2018 Schedule of Fees and Charges.
